

When a dog attack leaves someone hurt in the Atlanta area, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia is not one of them. Usually it comes down to whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
