

If a dog bit you in Georgia, the rules may not be what you assume.

Certain states [truck accident lawyer](#) impose liability regardless [local car wreck lawyer](#) of the animal's history. Georgia does not work that way. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
