

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and people tend to get hurt much worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene the same day, before you are out of the hospital. They begin building the company's side of the case right away.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
