

What the Anion Gap Measures

The **anion gap** is a practical way to look at **electrolytes** and spot subtle shifts in **acid-base balance**. It represents the difference between measured cations and measured anions in the blood, mainly using **sodium, chloride,** and **bicarbonate**. In practical terms, it helps clinicians recognize whether there are extra **unmeasured anions** contributing to a **metabolic disturbance**.

The concept is useful because routine **serum electrolytes** do not capture all charged particle in the bloodstream. $$\text{anion gap} = \text{sodium} + \text{potassium} - (\text{chloride} + \text{bicarbonate})$$

The numbers used come from a **serum chemistry panel**, which usually reports sodium, chloride, bicarbonate, and sometimes potassium. Because the result depends on the precision of those measurements, the calculation is only as reliable as the underlying sample and lab methods.

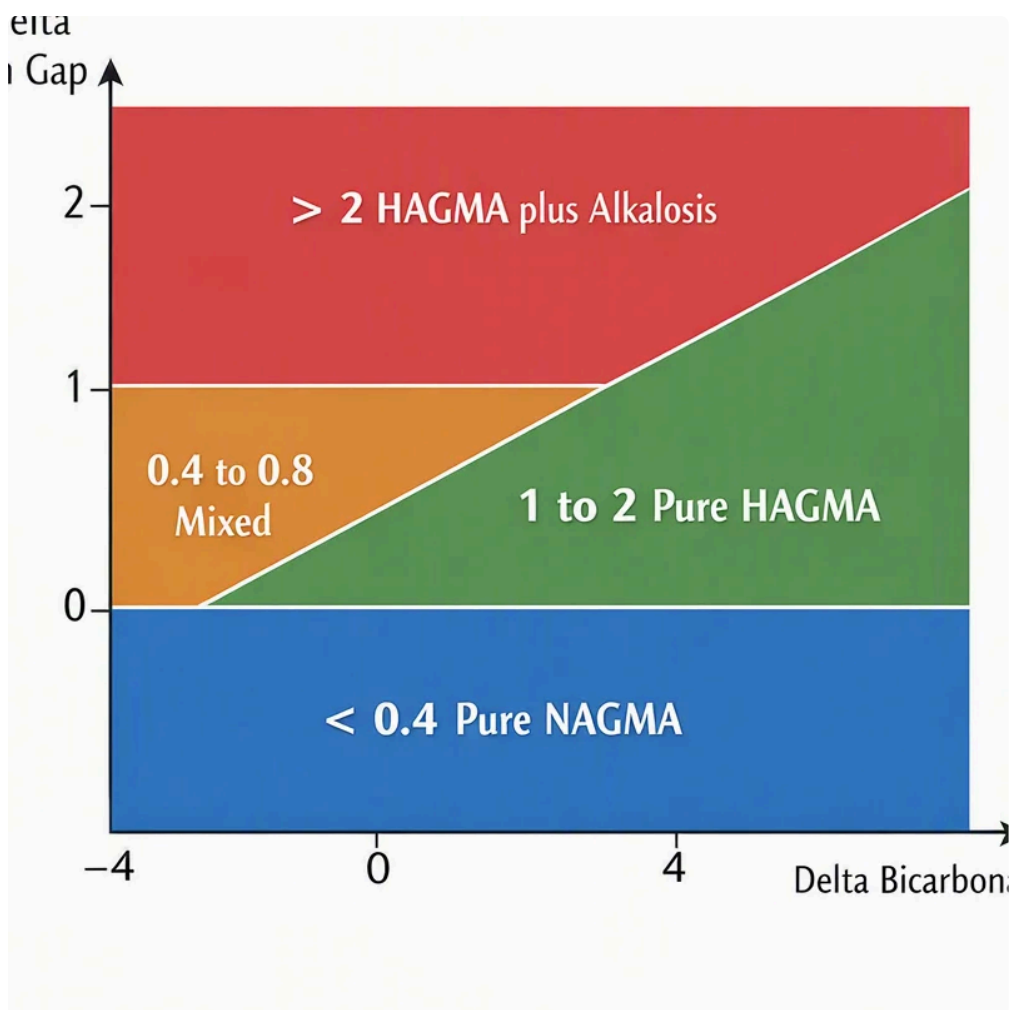
