

If you were hurt on a bus around Atlanta, there is a clock most people never hear about.

The general Georgia deadline <https://arthursuhg719.urbanvillum.com/posts/trip-and-fall-lawsuits-throughout-metro-atlanta-why-notice-decides-it> for injury suits is two years. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, in a specific form, to a specific office.

Missing that notice can end an otherwise strong case before it starts.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity questions and the coverage available.

Video is the other clock. Transit and charter buses carry multiple cameras, [truck accident lawyer](#) and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
