The Party Wall etc. Act 1996 Notice of proposed works under section 2 of the Act - Party Structure Notice

As the owner(s) of 62 Paul Road, Hitchin, Hertfordshire, SG5 5BL, which is adjacent to your premises at 61 Paul Road, Hitchin, Hertfordshire, SG5 5BM, we Brenda Willis of 62 Paul Road, Hitchin, Hertfordshire, SG5 5BL notify you that in accordance with our rights under section 2 of the Party Wall Act etc, Act 1996 we intend to carry out building works.

The proposed works are: Cut pockets no more than halfway into the party wall to allow steel beams to be inserted.

We intend to start work on or after 02 November 2020.

If you are content for the works to go ahead as proposed, please complete, sign and return the attached letter within 14 days of receiving this letter.

If you do not confirm in writing that you are content for the works to go ahead as proposed, we will be 'in dispute' under the Act.

If the event of any dispute between us under the Act, would you be willing to agree to the appointment of an 'Agreed Surveyor'? If the answer is yes, we suggest using Bright Futures Ltd of 92 Hertfield Avenue, Enfield, London, EN2 9QR but would be happy to receive your alternative proposal. If the answer is no, please let us know who you would like to appoint as your surveyor.
