Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Sometimes it fits. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Damage patterns carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
