

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Georgia law sets an order for who may **top personal injury firm Atlanta** bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Deadlines apply, and some of them are shorter than the general rule. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
