

If you ride and someone turned across your path in Atlanta, you are starting from behind.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.
