

If you or your child were bitten in Georgia, the rules may not be what you assume.

Some states hold <https://travisixot696.cloudhinter.com/posts/atlanta-personal-injury-lawyer> the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
