

A rideshare wreck raises a question a normal car crash does [Atlanta big rig accident lawyer](#) not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
