

If you ride and were hit in Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: **truck accident lawyer** that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Sight line analysis carry more weight than either version of events.
