

If an electrical injury happened at work in Atlanta, several companies may share responsibility.

There is the property owner, the [truck accident lawyer](#) general contractor, the electrical subcontractor, sometimes a utility, sometimes an equipment manufacturer, and sometimes a labor **Click for more info** supplier. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
