

If a dog bit you around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does not work that way. Usually it comes down to whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was <https://damienfruu044.quantlynix.com/posts/fatal-crash-claims-in-fulton-county-what-the-law-calls-the-full-value-of-a-life> restrained and whether anyone contacted animal control.

This evidence does not last. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
