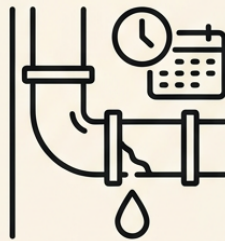
Event 1: External Flooding (Natural Disaster)

Damage is not sudden or accidental.
