

When a dog attack leaves someone hurt in Georgia, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. ***injury law firm in Atlanta*** Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
