If the app is off, it is an ordinary car wreck, and their personal policy applies. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
